As the year draws to a close, it's the perfect time to reflect on all we've accomplished together as a community in 2024.



Free Chlorine Burn Set to Begin in December

The City of Taylor public water system will temporarily convert the disinfectant use in the distribution system from chloramine to free chlorine. The conversion will begin on December 3 and continue through January 6. During this period, residents in Taylor may experience taste or odor changes associated with this type of temporary disinfectant conversion.

Public water systems are required to properly disinfect their water and

maintain an adequate disinfectant residual in the distribution system. Chloramine, free chlorine combined with ammonia, is widely used as a disinfectant because it persists for long periods while also limiting the formation of disinfection by-product contaminants.

Prolonged use of chloramine coupled with other factors that can impact water quality, such as high temperatures or stagnation of water, may result in the growth and/or

persistence of organic matter within the pipes of the distribution system, which may hinder the ability to maintain an adequate disinfectant residual. A temporary conversion to free chlorine, partnered with flushing activities, helps to rid distribution pipes of this organic matter and improve the quality of your water overall.

Downtown Master Plan

On Monday, November 18, the City held its second community meeting about the Downtown Master Plan update. At this meeting, residents were asked to weigh in on projects and features that should be added to the downtown master plan.

Wellness & Recreation Center Feasibility Study



The second community meeting for the Wellness and Recreation Center Feasibility Study was held on Wednesday, November 20. At the meeting, the results of the months-long survey were presented. The survey launched on September 25 at the last community meeting. There were two components, a statistically valid survey with targeted participants based on their demographics that reflect that of the community. This was a statistically valid survey with a 95% confidence level of accuracy. The second part was an online survey that anyone could take. The online survey has ended. The results of both surveys will be publicly available soon.

The team also presented preliminary analysis of the survey data combined with information gathered at the last public meeting and direction from the steering committee. Check out the video below to watch the presentation.

At the end of the meeting, there was a short activity to gain feedback on the spaces that were identified as a top priority, what people liked best, what people didn't like, etc.

DORIS ROZNOVAK AQUATIC CENTER UPDATE

Project Overview

The Doris Roznovak Aquatic Center has been a beloved gathering place for families all over Taylor for many years. Unfortunately, over the years the foundations of the pool have been failing and will soon no longer hold water. Because of this, the Parks and Recreation Department will soon embark on a reconstruction project to revitalize the Aquatic Center. A conceptual design created by Brannon Corp was approved by City Council in May 2024 to construct a new facility that will feature lap lanes, a lazy river, beach entry, water features, a play structure, and waterslide.

November Update

During the November 14 Regular City Council meeting, Council approved awarding a construction contract to GCreek Construction for the reconstruction of the Doris Roznovak Aquatic Center for a total of \$7,880,583.50. Funding for the project will come from the 2022 Certificates of Obligation Bond, 2024 Certificates of Obligation Bond, and 2025 General Fund dollars allocated for Parks projects.

Construction is anticipated to begin in early December 2024. The project is estimated to be completed by August 2025. .

ONLINE SHOPPING TIPS



Cyber Savvy Holiday Shopping

As holiday shopping ramps up, many Americans are more cautious with their spending this season due to ongoing economic uncertainty. According to insights from the National Cybersecurity Alliance (NCA), the key to safe and cheerful holiday shopping is staying vigilant against cyber threats that target online shoppers each year. Here's a quick guide on what to do—and avoid—to protect your wallet and information this holiday season.

Smart Cyber Practices

1. Monitor Your Financial Records: Keep a close watch on your bank statements and credit card activity to quickly catch any fraudulent charges. Reviewing your statements regularly and reporting suspicious transactions can be your first line of defense against identity theft.

2. Check Prices Twice: Knowing the standard prices for items can help you spot scams. Be wary of "deals" that seem too good to be true, as they may indicate counterfeit products or fraudulent websites. A little research goes a long way toward protecting you from untrustworthy sellers.

3. Follow the NCA's Cybersecurity Basics: The NCA recommends adopting these "Core 4" behaviors for online safety:

- Use unique, strong passwords for each account, ideally 12 characters or more, and consider using a password manager.
- Enable multi-factor authentication (MFA) on accounts that offer it.
- Set up automatic software updates to keep your devices protected.
- Be cautious with emails and messages, knowing how to spot phishing attempts and report them.

Shopping Pitfalls

Steer Clear of Public Wi-Fi for Purchases: Public networks can be easily hacked, making your sensitive information vulnerable. If you must shop on the go, use a secure VPN or mobile hotspot to protect your data.

Beware of "Grinch Bots": These automated bots buy up high-demand items to resell at inflated prices, often flooding the resale market with counterfeit or compromised goods. Buy only from verified retailers to avoid falling prey to "Grinch Bot" tactics.

Don't Overshare: While some data sharing is necessary to complete a purchase, you should be wary if a retailer is asking for excessive information. Share only what's necessary, and consider finding another vendor if a site asks for too much personal data.

HOLIDAY SAFETY TIPS

From the Taylor Fire Department



Your Taylor Fire Department wishes everyone a very Merry Christmas and wants to remind you that a safe holiday is an enjoyable one, here are a few tips to consider:

While decorating:

- Be careful with holiday decorations. Choose decorations that are flame-resistant or flame-retardant.
- Keep lit candles away from decorations and other things that can burn.
- Replace any string of lights with worn or broken cords or loose bulb connections.
- Read manufacturer's instructions for the number of light strands to connect.
- Use clips, not nails, to hang lights so the cords do not get damaged.

Holiday Entertaining:

- Test your smoke alarms and tell guests about your home fire escape plan.
- Keep children and pets away from lit candles.
- Stay in the kitchen when cooking on the stovetop.

Traveling:

- Prepare your car for winter and keep an emergency kit with you.
- Get a good night's sleep before departing and avoid drowsy driving.
- Leave early, planning for heavy traffic.

Reminder: Fireworks are not permitted in Taylor City limits. Let's keep our community safe and follow local regulations!
