## MDUS Status


Over the past year, the City Council has been considering establishing a Municipal Drainage Utility System (MDUS) for the city. One year ago, two public meetings were held to inform the public and to get input into the formation of the utility. Subsequently, the City Council created the Utility System by Ordinance in October 2009.

The city's aging infrastructure has had a significant impact on streets, bridges and drainage. Without resources to make these repairs and improvements, cities have found it necessary to create a special utility fund. Taylor and other cities such as Georgetown, Austin, Harker Heights and Belton use these funds to address their most critical drainage needs.

At the Council's August 12 meeting, a rate of \$1.00 per month for each ERU (equivalent residential unit) or 2,500 square feet of impervious cover was set. For residents, \$1.00 per month will be added to their utility bill beginning with the February 2011 bill. Commercial rates will be calculated on the square footage of impervious cover of the business.

A public hearing will be held on September 28, 2010 when the Ordinance will be officially introduced to establish the rate set to take affect January 1, 2011.

## Parks Grant Received

The City of Taylor has been awarded a \$75,000 grant from the Texas Recreation and Parks Account (TRPA) of the Texas Parks and Wildlife Commission. The matching funding required for the grant was the value of the land so no cash match was required.

These funds will be used to develop the five-acre park land at the entrance to the Taylor Regional Park & Sports Complex on Loop 397. The area already features a small fishing pond. New additions planned include a fishing platform, benches, a climbing boulder, trails and landscaping. The park is used by Taylor Middle School as an outdoor classroom.

## Growing Pains for Legacy Early College High School

This school year, the City of Taylor and the Taylor ISD are collaborating on hosting a bumper crop of 167 Legacy Early College High School students on the downtown campus of the East Williamson County Higher Education Center (EWCHC). Legislation requires the students to be taught on the college campus.

The City closed a portion of Fifth Street between Main and Porter Streets to accommodate four temporary buildings that hold eight classrooms for the Legacy students. The City Hall auditorium is being used as a cafeteria for the students who are required to eat on campus. Students may be seen gathering in the Heritage Square Park before class and throughout the day. The City is committed to providing support for this outstanding educational initiative as it continues to grow.

## Online Bill Payers Beware of Late Fees

Many customers are now using online bill pay through their banks to pay their water bills. The banks may indicate an estimated delivery date for the payment to be received at the Utility billing office. Unfortunately, many of these payments are not reaching the office by the due date and customers are incurring late fee penalties.

Many customers believe that the bank automatically debits their bank account for the charge and the Utility Billing office has received the payment. In reality, some banks mail a check that can take up to ten additional business days to reach the Utility Billing office. Additionally, if payment is not received by the due date on the late notice, an administrative fee will be assessed and water service can be disconnected.

Since some online bill payments through the bank may take several days to reach the billing office timely, online bill payments should be scheduled at least 10 days in advance.

An alternative to consider is signing up for an automatic draft from the bank account on the due date each month to avoid costly penalties and possible water service interruption. Contact the Utility Billing office at 512-352-2066 for additional information.
