Taylor Responds to Hurricane Rita Victims

The City of Taylor activated its Emergency Management Plan well in advance to begin preparations for Hurricane Rita. At midweek City staff and community partners were preparing for the worst as a category 3 hurricane was predicted for the Central Texas area. Taylor was not scheduled for an evacuee-shelter in Williamson County by the Red Cross. However, the City had made plans for providing a storm-shelter, if needed, as part of its Emergency Management Plan.

By Friday, weather forecasts changed considerably indicating the storm would be far to the east of the area. At an early Friday morning meeting, City Council members were provided a status report on emergency management activities. It was determined the storm-shelter was no longer needed and resources should be directed to providing a rest stop for weary evacuees coming through the area. Signs were posted on evacuee routes into Taylor directing travelers to the downtown Fire

Station where they could get snacks, drinks and information about Red Cross evacuee-shelters available to them in the Williamson and Travis county areas.

Later in the day, the Red Cross did request the storm-shelter to be activated to accommodate an overflow of evacuees in Williamson County. Forty-nine evacuees from Houston were placed in Taylor by the American Red Cross and Williamson County Emergency Operations Center. Designated evacuee-shelters in the Austin and Williamson County areas had reached capacity as coastal residents fled from Hurricane Rita.

Evacuees Placed in Taylor

Evacuees from Houston were hosted at the former Taylor Middle School cafeteria and gymnasium until mid-morning on Sunday. The community responded to urgent calls for cots, bedding, clothing, food and volunteers.
