
Bidding Underway For New Library, Fire Station and Park Restrooms

City staff and more than 30 contractors met at City Hall in a series of pre-bid meetings with engineers and architects to review plans for construction of the new Taylor Public Library, Central Fire Station and new Taylor Park Restrooms.


Plans for all three projects were prepared by Komatsu Architecture and represent more than \$5.1 million in funds issued in 2005 from the sale of General Obligation Bonds for the library (\$3.4 million) and fire station (\$1.7 million). The improvements for the park restrooms at \$355,000 were previously authorized from the 1998 General Obligation Bonds and 2003 Certificates of Obligation.

Bid openings are scheduled for November 10. Contracts will be presented for City Council consideration at their November 22nd meeting.

Construction is projected to begin after the first of the year.

2005-2006 Budget and Tax Rate Approved

The City of Taylor began a new fiscal year on October 1, 2005 with a budget increase of 4.1% over last year. With projected revenues expected to be slightly more than last year, the City Council approved a General Fund budget of \$9.35 million.

The Council also adopted an ordinance levying taxes for the maintenance and operation of the City government and for the interest and sinking fund for 2005-2006. The total tax rate per \$100 of valuation is \$0.7865.

This tax rate will raise taxes on a \$100,000 home by approximately \$46.50.

Credit Card Payments Now Accepted

City offices are now accepting MasterCard or VISA debit or credit cards for payments. City utility bills, permit fees and municipal court fees can all be paid in this manner.

A convenience fee of 3 percent will be assessed to customers wishing to pay by debit or credit card. Payments may be paid by phone as well as in person. Utility bills also can be charged automatically on a monthly basis. For additional information, please call the Utility Department at 352-2066.
